I trust this message finds you well. I am providing a final update on the review of the procedures and re-count related to the recent election of the board of directors and its officers. We re-counted 1268 ballots which remained unchanged from the original count of 1268 ballots.

Our team conducted a thorough evaluation of the ballot counting process to ensure the accuracy and integrity of the results. This review included a full re-count of ballots (hard and electronic) against the reported count, allowing us to verify the accuracy of the results. Additionally, we performed a quality control review of the ballot count documentation to ensure that all processes were followed correctly and the integrity of the document itself. To maintain objectivity, the quality control review was carried out by a completely independent team, separate from the initial counting team. Furthermore, an independent manager, who was not involved in the first counting process, oversaw the quality control review of the documentation. All aspects of this review were conducted under my supervision to ensure a high standard of accuracy and transparency.

After completing our review, I am pleased to report that the winners for the board of director positions and the winners of the officer positions **are accurate and remain unchanged**. We appreciate the trust you place in us to uphold the integrity of your electoral processes.


